Subject: THE USE OF PRIVATE CATEGORY AIRCRAFT FOR HIRE AND REWARDS (CHARTER SERVICES)

It has come to the attention of the NCAA that some aircraft imported by operators into the country under private category are being operated in Transport Category for hire and reward.

For avoidance of doubt, aircraft registered in Private Category cannot be used for hire and reward in Air Transport Category regardless of the state or country of registration. The Civil Aviation Act of 2006 and Nigerian CARs specifically prohibit this and any violation of the provision of these laws will attract the maximum of penalties which may include revocation of licences and seizure of aircraft.

We shall intensify our surveillance of private operators to ensure strict compliance with the licences and authorizations issued to them.
