**Subject:** NOTICE OF SUSPENSION OF SOME COMPANIES FROM PROVIDING AVIATION FUEL SUPPLY SERVICES TO AIRLINES AT AIRPORTS IN NIGERIA

This is to notify you that the Authority is in receipt of a letter from the Department of Petroleum Resources (DPR) that the under listed companies have no depot facilities and should not be engaged in aviation fuel distributions at the airport. The letter further asserted that the integrity and competencies of these companies cannot be ascertained by the DPR and advised the Authority that these companies be disallowed from further supply of aviation fuel to airlines at airports located in Nigeria.

These companies are:

1. Jushad Oil and Gas Limited
2. Lubcon Limited
3. Ascon Oil Company Limited
4. Acorn Petroleum Limited
5. Star Orient Aviation Limited

The Authority has required the Federal Airports Authority of Nigeria (FAAN) to deny access into airports in Nigeria to the above listed companies' aviation fueling vehicles and personnel until further notice.

### Action Required:

You are hereby required to suspend the fueling of your aircraft by any of these companies until further notice.

Please, ensure strict compliance.
